Eunice Medina currently serves as the chief of staff and deputy director of programs for the South Carolina Department of Health and Human Services (SCDHHS). SCDHHS is the single-state agency responsible for the operation of South Carolina's Medicaid program, through which 1.2 million South Carolinians receive their health care coverage.

Medina has extensive health care experience including more than 18 years of experience working in Medicaid policy, operations, and waiver programs. She joined SCDHHS in June 2021 where she serves as the top advisor to the agency's director and oversees the agency's quality, policy, strategic planning and research, managed care and provider and support services initiatives. Her prior public service includes her role as the bureau chief of Florida Medicaid's Plan Management Operations where she oversaw Florida's 18 Medicaid managed care plans.
